Investment and Endowment Committee Report

Mike introduced the members and staff of the committee. The committee met on October 3, 2024 to discuss the recommended draw. The members voted unanimously to approve a total amount of \$10,800,000 for 2025 consisting of administrative fees and draw on investment. The draw is based on average balances of the proceeding 20 quarters based on all of the funds available. The actual draw is from the unrestricted funds.

Finance and Budget Committee Report

Mark introduced the committee members. The committee has three items to come before the Board. There has been good performance in investments. Expenses have come down over the past year. An increase in revenue of 2% is estimated in the upcoming year. The budget is balanced without a dramatic change in draw. National Setting staff will see the cost of living allowance increased by 3.4%. Healthcare and dental costs have increased.
